HB4521 Unbalanced Budget Response Act will be heard Thursday, including sweeping of 911 funds. Revenue Committee – Chairman John Bradley meets in room 118 in the Capital Building at 0800 hrs., Thursday, May 5th. Defer the rest to old business.

ATTORNEY'S REPORT –Fronk shared he attended a meeting with the ETSB, 911 Authority, and PSAP workgroup. AT&T - AT&T presence was requested due to an outage in the Antioch area on April 7th. Chief Nixon expressed his concerns and discontent with AT&T and their lack of communication with the appropriate personnel. Representatives from AT&T advised the Antioch central office is a remote site off of Libertyville. The CO was isolated off due to a technician causing damage to fiber in a vault. The outage impacted 911 services for the customers calling outside the Antioch exchange but did not cause any 911 circuit failures to any PSAP's. An Everbridge notification was sent out to FoxComm and CenCom advising of the service outage. AT&T did explain the Everbridge system is controlled and managed by the 911 resolution center and not the corporate entity. Discussion ensued reference the content of the message that was sent to the PSAP's as it appeared confusing that 911 could not be called from a customer's phone. AT&T relayed they will be coordinating with the 911 resolution center to add additional notifications and attempt to better clarify future messages. Nixon advised while he appreciates AT&T's efforts, the lack of communication to the emergency services that 911 calls could not be completed to PSAP's which are located outside the Antioch exchange is extremely concerning. If proper and more concise notification had been made contingency plans could have been put into effect to ensure the safety of the public should an emergency have arose. AT&T again assured that they would investigate and relay our concerns to the proper departments.
