Proposed process to update Lake County "An Ordinance Providing for the Establishment of the Emergency Telephone System Board for the Lake County 9-1-1 Service Area and Setting Forth the Powers and Duties of Said Board" approved as amended May 14, 1996 by the Lake County Board. – McEwan advised process still on hold.
