ETSB Director – McKenzie advised he met with Venturi and they reviewed job descriptions from other ETSB Executive Director positions. A draft job description has been created and will be posted by Lake County HR after review by the members at the April 2019 meeting.

Tellus (FATPOT) upgrade – Winnecke advised there have been previous conversations and presentations for the Tellus upgrade. Winnecke shared he had a meeting with Vernon Hills and NWCDS has previously expressed interest in moving forward with the CAD to CAD interoperability upgrade. Members agreed to have ETSB staff proceed with obtaining updated pricing.

NEW BUSINESS:

Purchase of Communications Analyzer / Tuner - Motion McKenzie, second Huffman to approve purchase of Freedom Technologies R8100 Communications system analyzer from Freedom Communications Technologies not to exceed \$46,370.00. Budget line 84030. ETSB

shall develop a policy for use. Discussion – Winnecke presented proposed action item overview as provided by Chair Dato. McKenzie reviewed the technical specifications of the analyzer and advised yearly maintenance on radios using a vendor can be expensive and hard to coordinate without impacting operations. Steingart asked Fronk if the purchase of this equipment falls within the statutory guidelines of the ETSA. Fronk advised based on previous AG opinions, it falls into the statute for devices assisting in the dispatch of emergency responders. Buschick inquired about ongoing maintenance costs for the analyzer, if all features on the quote are needed, and if the use of the analyzer is intended for ETSB member agencies. McKenzie advised the first 5 years of maintenance is included in the purchase price, all the features on the quote are needed, and the intent of the purchase is to maintain ETSB member agency radios. McKenzie advised the analyzer could potentially be used for non-member agencies if agreements are reached. ETSB will draft a policy on use, authorized access, accountability, and storage of the analyzer before deployment.
